CALL FOR PAPERS

The Competition Law Journal (*Revista de Derecho de la Competencia*) is a publication of the Centre for Studies in Competition Law –CEDEC- at the Javeriana University in Bogota, which has been edited since 1997. This year, the Journal reached its fifteenth publication, which corresponds to the eleventh number of the Competition Law Journal.

The main objectives of the Journal are the following:

- a) Present to the Colombian and Latin American academic communities the results of research and reflection of important experts in Competition Law.
- b) Contribute significantly to the discussion of the legal and economic issues related to free competition.

The publication is divided in three sections: Articles from foreign authors, articles from Colombian authors and a debate section, where trendy subjects and recent decisions from the Competition Authority are presented.

For this year's number, papers must be related to Competition Law issues from scholars', practitioners' or competition authority's officers' perspective. Preferably, articles should not exceed 35 pages, but exceptionally, the Editors may consider admitting longer papers.
